DUES INCREASE PASSED at State

- 1. Whereas the Colorado State Grange has been receiving a substantial amount of money from Grange Insurance Association (GIA) via the National Grange per a trademark agreement and
- 2. Whereas those monies were reduced again for the coming year by \$4,000.00 and
- 3. Whereas the Colorado State Grange has not had a dues raise for the state Grange since approximately 1998 and
- 4. WHEREAS the Bureau of Labor Statistics (BLS) Inflation Rate indicates that the cost of something in 1999 that was \$20, would now cost nearly \$31.00 in 2019 and
- 5. Whereas the Grange is one of the most economical organizations to belong to and
- 6. Whereas raising the Colorado State Grange Dues by \$10.00 per member would make an individual's dues \$24.00 to the State Grange (not including National dues or the Local Grange's dues) now therefore be it
- 7. **RESOLVED** that the Colorado State Grange raise membership dues \$10.00 per member.

So this means that dues for Marvel Grange members will now be \$41.00 per person/year for regular members who are not golden sheaf members. If you need to break your dues payment up into small portions please discuss the possibility with Secretary, Sheryl Ayers. Dues are due January 1, 2020.
