VOTERS FAVORABLE TO AGRICULTURE

Sustainability.

It's a word that means widely different things to different people. Sustainable agriculture is defined by the 1977 and 1990 farm bills as a system that will satisfy human food and fiber needs, enhance environmental quality, use resources efficiently, sustain the economic viability of farmers, and benefit society as a whole. How confident is the public about agriculture's commitment to sustainability?

The Morning Consult (public policy newsletter) recently asked 1,917 registered voters to give their opinions regarding agriculture and sustainability based on the farm bill definition. Mostly, Americans think agriculture and farming are among the nation's most sustainable sectors. Here are some interesting responses from those polled:

Agriculture is sustainable. Among Republicans 80 percent say yes and 76 percent of Democrats agree that agriculture is sustainable

Incentives are best. Cooperative incentives that allow government and farmers to work together to address issues is preferred over farm regulation

Respondents said they trust farmers to make the right decisions about sustainability

Respondent's favorability ratings for several major U.S. business sectors were, agriculture 78 percent, technology 76 percent, hospitality industry 73 percent, manufacturing 67 percent, energy 60 percent, airlines 54 percent and pharmaceuticals 43 percent.

A huge majority of respondents agreed with the statement that "the true success of environmentally sustainable farming depends on whether that practice also leads to economic opportunity for the farmer."

RESOLUTIONS

It's NOT TOO EARLY TO SEND IN Resolutions. The National Grange will be focusing a lot of energy on the 2018 Farm Bill.

Every five years, Congress passes a bundle of legislation, commonly called the "Farm Bill" that sets national agriculture, nutrition, conservation, and forestry policy.

So NOW is the time to get resolutions in concerning the Farm bill which happens to include a lot of other areas that are affected because they deal with "food" for people and animals.

I recently noticed an article in our local paper concerning the Colorado Legislature's progress on a Rural Broadband bill and a Transportation bill.

Please take time to consider resolutions and send them in to the state office. We'd really appreciate it if you didn't wait until the last minute before state session September 21-23 in Colorado Springs.
