## CONVENTION MINUTES Friday, September 23, 2022

The Grange was opened in the Fourth Degree at 8:45 a.m. by State Master, Gary Wardle. The roll call of officers was taken with Lisa Mittan, protem for Lecturer, and Norm Union protem, for Gate keeper. John Cruz moved the minutes be approved by the executive committee.

The Final credential report was given with 25 delegates present. Election committee consisted of Larry Corman, Tom Campion and Norm Union.

Election of officers was held with the following results: Roger Ayers was elected to serve on the executive committee for three years. Elizabeth Hiner was elected Lecturer, Kendall Spoor was elected Steward.

Committee reports began simultaneously with the election. Lisa Mittan brought one resolution from the Ag committee to the floor. It was sent back to committee after much discussion.

Roger Ayers, Good of the Order committee brought 102 to the floor. It was amended in committee and adopted. We took a short break.

Birgit Landin, Colorado Spring Utilities member, was introduced. She began by asking where individual lived in regards to water areas in the state. She shared information about the various river basins in Colorado and some of their use. Colorado is a headwater state. Colorado can only keep 1/3 of its water. She shared information about the compact agreements with surrounding states. Upper basin states and lower basin states. California gets the most water from our state. Colorado is second. A problem has arisen because Colorado has not been producing as much water as in the past. 1 acre foot of water is about 326,000 gallons of water. She discussed what water is used for in the state – Agriculture uses 86%. She talked about water rights. Every drop of water is considered a public resource. It can be purchased. Water rights are not tied to the land. Sr rights and Jr rights exist in water regulations. Sr rights go back to 1880. 1 acre foot of water can sell upwards to \$40,000.00.

She discussed water collection for Colorado Springs. There are seven collection systems, water is transported form 100 miles away, 25 reservoirs to store three years of supply for Colorado Springs. CS goes through 68,000,000 gallons of water a day. She showed a U.S. Drought monitor map of Colorado. There are 19 tunnel systems through the Rocky Mountains to transport water from the west slope to the east slope. Four are for Colorado Springs. Master/President Gary Wardle presented her with copies of our History and a Cookbook.

The meeting was called back to order after a 5-minute break. Work on resolutions continued. GOTO, Roger Ayers, presented 103 on the Investment policy. The resolution was amended and the Policy was amended. Resolution was approved with amendments.

Larry Corman, budget committee presented the 2023 budget. Questions were answered and the budget was approved.

Alan Caldwell suggested that we consider doing the Granger in a different way. Perhaps e-mail and a limited number of mailed copied. He suggested the subordinates consider making copies of the publication to give to members who do not have e-mail. Discussion led to a suggestion that this topic should be drafted as a resolution. Gary Wardle suggested that a committee be formed of individuals with knowledge on how to develop a plan for the Granger. Grangers are encouraged to volunteer by contacting Gary Wardle. Amy Peterson suggested that those who want to get the e-mail version sign up. Barry Willits, volunteered. Lisa Mittan, (IT) volunteered.

The meeting recessed for lunch.

Welcome to the 149<sup>th</sup> Annual Convention of the Colorado State Grange in Fountain Colorado. It is my honor to serve as the president of the Colorado State Grange. The Colorado State Grange was formed in February of 1874. One would think this is the 148th convention, but there were two conventions in 1874 to form the state Grange, one in January and the second in February to complete the process. There were 44 Granges in attendance. The 150<sup>th</sup> Birthday of the Colorado State Grange will be in 2024. We will be planning the 150th Birthday celebration in 2023 for 2024.

Congratulation to the Granges in Colorado who persevered through the past two years of COVID restrictions. The Granges have continued to do good work to support their communities through these trying times. Between the first and second quarters of 2022the Colorado Grange membership grew by around 50 people. Great work by those Granges that grew.

As we begin the new year, I would encourage all presidents to have a planning meeting to identify programs and events for your Granges to support your community. As you develop the events and programs, it is helpful to have a Facebook page to advertise to the Grange events to the community. You should try and involve the community in your events. As your community gets involved in the event, it is important to realize an opportunity to gain new members is provided. ## **National Grange**

In November, Kathy and I attended the National Grange convention held in Wichita, Kansas. Thank you to Cindy Greer and Elizbeth Hiner for their work as representatives from Colorado on the regional convention committee. Sheryl Ayers and Ruth Wilson Francisco assisted in the presentation of the 6<sup>th</sup> degree.

The delegates to the National Grange approved a resolution to sell the National Grange office building in Washington DC. Advertising the sale began in January. There have been several offers, but none have moved forward.

## Legislative

The state has received a large sum of money from the Federal government to expand broadband services into the rural areas of the state. There will be opportunities for all to participate in the process to let the state know where there is a need to expand broadband services. We will put information in the paper giving notice of the opportunities. All should watch your local news for ways to participate. This year is the mid-term election. There are eleven measures on the ballot. The measures include reducing the state income tax, allowing grocery stores to sell wine, appointing judges to the new 23 Judicial district, allowing the use of a portion of the income tax to fund affordable housing, and more. We should all become knowledgeable on the ballot measures and vote in November.

- There are 38,800 farms in Colorado.
- The average size of the farm is 820 acres.
- 81.4% of the farms are individually owned, 8.2% are partnerships, 7.3% are cooperate farms.
- Farm cash receipt were \$7.28 Billion. Livestock was \$5.14 Billion, and Field, Fruit & Vegetable crops were \$2.13 Billion
- There are 2,8 million head of cattle and 750,000 pigs
- Since 1978 Colorado's wine industry has grown to more than 160 licensed wineries

I appreciate the guidance, assistance and patience of Larry Corman, Tom Campion and John Cruz and Harry Greer, Executive Committee; Gary Wardle, State Master; and Cindy Greer, State Secretary, during the last couple years. You may rest assured they all are on top of our financial activity and current or changing situation.

Thank you for entrusting me with the privilege and responsibility of being your treasurer.

## **Secretary's Report**

Cindy Greer

My first year as the Secretary of the Colorado State Grange has been a learning experience. I now have a greater respect for those who have served in this position before me.

Immediately after State session I had to learn how to file the report with the post office to keep our periodical (the Colorado Granger) permit active and to figure out how to make payments to them. This is something that has to take place every year prior to October 1. In October the USPS initiated a new system, EPS, or Enterprise Payment System which was supposed to make life easier. It took some time to get the EPS account established and up and working but we did finally achieve success. The USPS help line misinformed me, telling me that I could make a deposit on our account at **ANY** post office. Those individuals were mistaken because we can make deposits to postal one post offices but not manual post offices, which is what is nearest to me. After initially trying to make a deposit with a new Postal worker at a manual office and being a pest, we finally got our money back after six months of trying.

There were many changes of address communications that took place at the beginning of my term which took quite a bit of time.

I've experienced some challenges with the excel program doing things that I didn't tell it to do when I sorted out the list for the Granger mailing and the program mixed up the last names of most of the people on the list. I did learn that several individuals do look at that portion of the paper.

As many of you may recall you did not receive a Colorado Granger in November. Unfortunately, the paper got lost somewhere between the publisher and the post office and to date none of us have seen our individual copies. Maybe some year down the road they will get delivered. On the first of the month that articles are due for the paper I send out an e-mail reminder. If you are not on that list and would like to be please let me know and I will add you to the group. Articles for the paper are due on or before the 15<sup>th</sup> of the month prior to when it goes out. Articles are formatted and read for grammatical and spelling errors by myself and Gary Wardle, which doesn't mean that we catch all the errors, but at least we try. We send the articles to Publication Printers within a couple of days after the 15<sup>th</sup> in order to give them time to format them into the paper, get us a proof to approve and then to print and deliver to the Post office. Unfortunately, with periodicals they sometimes sit in the post office for quite a while before they get delivered.

Completing the Journal of Proceedings was an easy task, but the Roster was a different story. Again, the computer erased Granges and names that I know were there for a while, but when I printed it, they had disappeared and I didn't discover that until after they were mailed out. But we did send out the information at a later date. I also put the Roster in an excel format for those who like things on the computer.

As I've read for many years the majority of the secretaries time is spend on keeping the membership records up to date. This is true. With each quarterly report there are two documents to update with new members, dropped members and change of addresses. Sometimes we know of address changes because the post office sends back papers that they can't deliver due to various reasons. The Colorado State Grange keeps an excel list of Grange members and we update the National Database with changes in our state as well.

At the end of the second quarter for 2022 Colorado has 1077 members. Fifteen family plans with 40 family members, three exempt Golden Sheaf Members, 38 Non-exempt Golden Sheaf Members, 32 Associate members, 2 affiliate members and 45 Junior members. The Junior members are not counted in our total membership. Golden Gate Grange is our largest Grange with 172 members. Redlands Mesa Grange has 60 members, Altona Grange has 51 members, Left Hand Grange has 47 members, and Animas Valley has 46 members. We have a total of 38 subordinate Granges in the state. Fountain Valley Grange and Liberty Hall Grange relinquished their charters this year.

National Good Day magazine prints the names of new members. We have sent in our new members names as requested. Colorado has 94 new members in our Granges.

Marvel, Green Valley, Pleasant Park and Grandview Grange requested membership awards this year. Three Golden Sheaf Awards, five – 55-year seals, Two – 60-year seals, one- 65-year seal, one – 70-year seal and one 81-year award. National has increased the price of the Golden Sheaf (50) and Silver Star (25 year) certificates and added postage. The seals are now \$3.00 each and I do have a few available in the office. National also has Members appreciation certificates available to recognize members with 5, 10, 15, and 20 years. They do plan on having 1-4 year, 6-9-, 11-14-, and 16–19-year recognition certificates available.

As Secretary I have taken minutes for the Executive committee meetings which have been held via Zoom. I also participated in a Zoom conference that the National Grange Secretary held earlier in the year and was unable to participate in the July conference due to our Pomona meeting. Gary Wardle did participate in this meeting in my absence.

Exempt Property reports were received and sent out to each Grange. I am pleased to report that all Granges returned those reports and they were mailed to the proper authority.

Quarterly reports have been sent out about 15 days before the end of each quarter. Most Granges are good about getting their reports back to me in a timely manner. We do have two Granges that have not yet reported this year. The State's quarterly report is due 60 days after the end of the quarter and if I don't have your reports before that I just have to assume that nothing has changed and report the last number of members that was reported.

We transferred the State Grange telephone number in Florissant to a cell phone, so we should have the same phone number as we change locations and secretaries. If you have suggestions on how we can improve what we do please feel free to share those with us.

Last year we discovered that there was a CD in the unclaimed property with the state of Colorado for the Colorado State Grange Youth. We filed the paperwork and successfully retrieved those funds.

It's important for Granges, Subordinate and Pomona to file their 990N Postcard reports with the IRS. Doing so ensures that you retain your current tax-exempt status, once you lose that status you have to file new paperwork and pay around \$600.00 to get your status back. Having the status prevents your Grange from having to pay taxes.

The National Grange is changing the bonding deadlines. This year in order to having bonding you must send your payment before December 1 for 2023.

Thank you for your patience with me as I learn all of the different aspects of this office.

## Annual Agriculture Report David H. McCord, Agriculture Director

Due to remaining considerations for the pandemic during much of the past year my ag activities were limited to the quarterly reports for the Granger and monitoring ag issues including the dilemma of the lack of water in the Colorado River drainage. The Ag Council held two meetings via Zoom and due to technology errors, my participation was short. No summer meeting was held

The Ag Council hosted the Ag Day at the Capital with goody bags, luncheon, and opportunities for educational seminars. I did not participate seeing minimal opportunity for the common interactions that were so much a part

of Ag Day celebrations in the past. Their intent is to showcase Colorado's abundant food products. The Ag Council commonly hosts a summer and fall sessions to best identify current issues and needs with the Fall session focused on the upcoming legislation session. The one upside of the lowered activity is that with few financial needs, no dues are being charged to member organizations.

Of interest, the Colorado Fruit and Vegetable Growers Association has grown from a small group of farmers a few years ago to a vibrant and active organization with an estimated membership over 100 individual farms and allied organizations. "Helping farers provide a wide range of nutritious produce to Colorado and other states." I am not a member but see their regular emails and meeting notices.

Likewise, the Colorado Wildlife Conservation Project has emerged as a combined force of about 20 sports men and sports women organizations to best combat radical and extremist in favor of rational, reasoned, and science-based management of our wildlife resources. Members include the Rocky Mountain Elk Foundation, Teddy Roosevelt Conservation Partnership, Muley Fanatic Foundation, Back Country Hunters and Outfitters, Muzzleloading Association, Colorado Trappers, Big Horn Society, National Wildlife Federation, Trout Unlimited, and others. The group grew out of the realization that the anti-hunting organizations such as the Humane Society of the United States have a long view of their programs and a big budget. Colorado's proposed "cat bill" of early this year largely sponsored by the HSUS would have made it illegal to trap, kill, or hunt mountain lions, bob cats and lynx. The Colorado Wildlife Conservation Project grew out of the combined opposition to that bill. Members are also closely involved with the planning for introducing wolves as approved by the voters.

Kay and I attended the Colorado Ag Commissioner's "ice cream graze" at the State Fair where we also met up with Harry and Cindy Greer and State Master Gary Wardle and First Lady Kathy. Of interest, Kay and I were in line at a food booth and the Commissioner was likewise in line with a group. One of them separated and came over and said "hi, I am Jared Polis" as in Governor.

#### **Legislative Director Report**

Mike Lackey, Legislative Director

As we are wrapping up my first year of being the Colorado State Grange lobbyist. I selected the following committees to report on due to the Granges link to Agriculture. The committee results are Agriculture, Water and Natural resources.

#### **AGRICULTURE**

During the 2022 legislative session, the Colorado General Assembly considered measures related to agriculture, including wildlife and conservation, workforce, the Colorado State Fair, and other agriculture-related topics. Wildlife & Conservation. The General Assembly considered several measures focused on habitat and species conservation. The Habitat Partnership Program works with local communities to develop partnerships to meet game management objectives and reduce conflicts with big game species, particularly related to forage and fence issues. House Bill 22-1072 extends program funding indefinitely. Beginning in FY 2023-24, the bill continues annual transfers of big game license fee revenue from the Wildlife Cash Fund to the Habitat Partnership Program Cash Fund, estimated at about \$2.5 million each year. In an effort to conserve native species, Senate Bill 22-158 appropriates \$6.0 million from the Species Conservation Trust Fund for programs submitted by the Director of the Department of Natural Resources (DNR). The programs are designed to conserve native species that are threatened or endangered under state or federal law, or are likely to become candidate species as determined by the United States Fish and Wildlife Service. Colorado Parks and Wildlife collects data on the location of animals and sensitive plant species and habitat as part of regular operations. Under current law, this data is a public record subject to request under the Colorado Open Records Act (CORA). Senate Bill 22-169 amends CORA to exclude

the portion of any public record that could reveal the location of animals and sensitive plant species or habitat. Workforce During the 2021 legislative session, the General Assembly passed Senate Bill 21-087, which required that agricultural worker employers provide some workers access and transportation to key service providers, provide overwork and health protections, and increase protections and safety precautions during public health emergencies. House Bill 22-1308 creates the Agricultural Workforce Services Program to help employers meet the standards set in SB 21-087. The program consists of an online resource portal for agricultural employees and employers and a grant program for workplace improvements or changes to comply with labor and workplace standards. SB 21-087 also required an agricultural employer to meet specific housing requirements for agricultural workers during a public health emergency. House Bill 22-1313 clarifies that these requirements apply only during a statewide public health emergency related to COVID-19. The bill also includes alternative protections related to housing as Agriculture (cont'd) h Page 2 h identified by the Department of Public Health and Environment (CDPHE). Colorado State Fair. The General Assembly considered two measures focused on the Colorado State Fair. In response to the performance audit of the Colorado State Fair Authority (authority) by the State Auditor, House Bill 22-1022 implements certain recommendations from the audit. These recommendations include: · clarifying that the Commissioner of Agriculture, in consultation with the authority board, will appoint and employ a manager for the authority; · requiring the authority board to establish a process for approving industry displays at the fair; and · allowing the authority to collaborate with a state agency or industry representative in developing an industry display. Senate Bill 22-013 increased the size of the Board of Commissioners of the authority from eleven to thirteen members by adding an at-large member and a member from the new eighth congressional district. After SB 22-013 was signed into law, Senate Bill 22-042 changed the board's composition, requiring two members from each of the four agricultural districts in the state instead of members from each of the eight congressional districts. This bill also set terms and appointment dates, as well as requirements for members regarding occupation, agricultural experience, residency, and political party affiliation. Other Agriculture-Related Bills Senate Bill 22-209 requires the Commissioner of Agriculture to hire an employee or engage a contractor to help small meat processors and people trying to start a small meat processing business apply for and obtain grants and loans offered by the United States Department of Agriculture and other entities. The program is repealed July 1, 2024. In an effort to address pollinator health in Colorado, the General Assembly passed Senate Bill 22-199. The bill directs DNR to study and develop recommendations on how to address pollinator decline and increase pollinator health in the state. Recommendations may include the protection of native pollinating insects, best practices for state agencies in implementing policies and practices regarding native pollinating insects, and how to develop education and outreach programming. An additional bill on native pollinators – Senate Bill 22-131 – was postponed indefinitely. Beginning with property tax year 2023, House Bill 22-1301 defines a controlled environmental agricultural (CEA) facility as a nonresidential structure and related equipment combining engineering, horticultural science, and computerized management techniques to optimize hydroponics, plant quality and food production efficiency from the land's water for human or livestock consumption. The bill also specifies that: · a CEA facility will be valued for assessment purposes as all other agricultural property using the cost, market, and income approaches; · agricultural equipment used in a CEA facility is exempt from property tax; personal property used in the operation of a CEA facility is exempt from property tax; and · a CEA facility may not be used to grow marijuana or any other nonfood crop agricultural

## WATER

During the 2022 legislative session, the General Assembly considered several measures related to water, including water project funding, groundwater sustainability, watershed resiliency, turf replacement, and other water related efforts. Water Project Funding Every year, the General Assembly considers a water projects bill that appropriates funds for a variety of Colorado Water Conservation Board (CWCB) projects. House Bill 22-1316 appropriates about \$17 million from the CWCB Construction Fund to CWCB and the Division of Water Resources for specified water-related projects. This was the first year that sports betting tax revenue was directed to the CWCB Fund. In 2019, voters approved Proposition DD, the Legalize Sports Betting with Tax Revenue for Water Projects Measure. The measure allowed for the taxation of sports betting operations and the use of the revenue to fund state water projects. Funding coming from the new sports betting revenue includes: •\$8.2 million

for the purpose of implementing the state water plan; \$2 million to support compact compliance in the Republican River Basin; and · up to \$13.13 million for loans to the town of Breckenridge to rehabilitate the Goose Pasture Tarn dam. Groundwater Senate Bill 22-028, which was recommended by the Water Resources Review Committee, created the Groundwater Compact Compliance and Sustainability Fund and appropriated the \$60 million in federal American Rescue Plan Act (ARPA) revenue to help finance groundwater use reduction efforts in the Rio Grande and Republican River basins. Wildfires & Watersheds the General Assembly also directed \$20 million in ARPA funds for wildfire mitigation and watershed restoration. House Bill 22-1379 appropriates the following: \$3 million to support wildfire risk mitigation and watershed resilience; \$2 million for wildfire mitigation and fuel reduction projects; and .\$15 million for watershed restoration and flood mitigation grants. Recipients of the funds include the Colorado State Forest Service and the Department of Natural Resources. Turf Replacement In an effort to reduce water use across the state, House Bill 22-1151 requires CWCB to develop a Water turf replacement program to incentivize voluntary replacement of nonessential irrigated turf on residential, commercial, or industrial properties. CWCB must develop the program before July 1, 2023. The bill creates the Turf Replacement Fund and appropriates \$2 million annually and authorizes local governments, nonprofits, and Native American tribes to apply for funds. CWCB may also contract with third parties to turf replacement programs in areas where local programs do not exist. Other Water-Related Bills There are currently 16 irrigation districts in Colorado that operate to raise money for large irrigation and drainage projects and are controlled by local landowners. House Bill 22-1092 allows an irrigation district board to borrow money, which can then be loaned to landowners. The money from the loans may be used to make improvements to private water delivery systems or towards projects that improve water conservation or efficiencies on landowner property or landowner delivery or drainage systems. The 2021 interim Water Resources Review Committee recommended a bill that was meant to strengthen Colorado's anti-speculation laws. Senate Bill 22-029 would have allowed for the State Engineer to investigate the sale or transfer of agricultural water rights. The bill did not pass through the Senate Agriculture and Natural Resources Committee. In an effort to protect water rights in Colorado, Senate Bill 22-126 would have given first priority to projects funded from the CWCB Construction Fund that increase or improve undeveloped compact-entitles water storage in the South Platte River basin. The bill was postponed indefinitely by the House Agriculture, Livestock, and Water Committee.

products. Senate Bill 22-205 authorizes CDPHE to create rules that prohibit intoxicating

#### NATURAL RESOURCES

During the 2022 legislative session, the General Assembly considered several measures related to natural resources and the environmentincluding wildfire prevention and control; air quality; natural resources; environmental protection; and recycling.

Lawmakers recognized the importance of addressing wildfires and passed a number of bills to mitigate their frequency and intensity. Two bills direct the Colorado State Forest Service (CSFS) at the Colorado State University to address wildfire mitigation through public awareness and information sharing. <u>Senate Bill22-007</u> convenes a working group led by the CSFS to consider how to best conduct an enhanced wildfire awareness month outreach campaign in 2023 and

2024. This includes marketingtactics, educational events, an outreach campaign, technical assistance, amongoth er strategies. *House Bill 22-1012* requires the CSFS to develop a publicly accessible statewide carbon accounting frame work and a forest carbon co-benefit framework for project

accessible statewide carbon accounting frame work and a forest carbon co-benefit framework for project level forest management, including wildfire mitigation.

A fire suppression pond is a pond that containswater used exclusively for fighting active fires. <u>Senate Bill 22-114</u> encourages local jurisdictions to create these ponds by allowing county commissioners to consult with their fire protection district to identify a fire suppression pond in high-risk areas of wildfire damage. The commissioners can then apply to the Colorado Department of Natural Resources for an official designation.

#### Air Quality

The air quality in Colorado is an increasing concern to lawmakers, and the General Assembly considered several bills on the topic. *House Bill 22-1244* seeks to prioritize the health of communities impacted by air toxins. It creates a new program in the Department of Public Health and Environment to regulate toxic air contaminants. The bill also requires certain businesses to submit annual toxic airemissions reports and creates a monitoring program. Additionally, it requires the Air Quality Control Commissions to identify up to five priority toxic air contaminants, establish health-based standards, and adopt emission-control standards.

#### Senate Bill 22-193 offers a set of initiatives

to address Colorado's air pollution, including funding forelectric school buses and ebikes and clean air grant pr ogram to reduce air pollutionfrom industrial andmanufacturing options. Additionally, it creates the Cannabis Resource Optimization Cash Fund, which creates incentives to encourage sustainable practices in cannabis operations. The bill also modifies definitions, reviews form and filing

requirements, addresses hearing deadlines, andmakes changes to the legislative review process. The General Assembly considered several bills concerning natural resources including chemical use,

geothermal energy, and waterquality.

<u>House Bill 22-1348</u> addresses chemical use by the oil and gas industry. The bill requires operators,

House Bill 22-1348 addresses chemical use by the oil and gas industry. The bill requires operators, providers, and direct vendors that provide chemical products directly to an operator at a well site for use in underground gas and oil operations to disclose chemical use information to the Colorado Oil and Gas Conservation Commission. The department must thencreate a web-based chemical disclosure list.

<u>House Bill 22-1381</u> creates the GeothermalEnergy Grant Fund in the Colorado Energy Office. The grant program provides funds to invest in geothermal energy, including heating, cooling, and electricity generation.

The Environmental Justice Act, enacted by <u>House Bill 21-1266</u> required the Air Quality Control Commission to gather input from disproportionately impacted communities. <u>House Bill 22-1322</u> extends these requirements to the Water Quality Control Commission (WQCC). Additionally, the bill requires the WQCC to designate use-protected water and creates a 5-

year statute of limitations forbringing actions under the Colorado Water Quality Control Act.

#### **Environmental Protection**

Environmental protection was a topic of much deliberation in the 2022 legislative session. Polyfluoroalkyl (PFAS) chemicals are manmade chemicals prevalent in products like nonstick pans, cookware, and water-repellant clothing that break down slowly over a long period of time. *House Bill 22-1345* phases out PFAS chemicals in carpets, furniture, cosmetics, juvenile products, and some types of food packaging, as well as in fluids used in producing oil and gas. It also requires cookware with PFAS to be labeled. The amended bill additionally prohibits the use of Class B firefighting foam that intentionally contains PFAS chemicals at structures used for the storage of maintenance of aircrafts located in an airport beginning January 1, 2024.

Colorado's unique geography includes diverseecosystem and various communities of native pollinating insects. Native pollinating insects are necessary for protecting Colorado's ecosystem. <u>Senate Bill 22-199</u> requires the Colorado Department of Natural Resources to study the declining native pollinating insects and create a recommendation to address the pollinator decline and improve pollinator health.

## **Recycling**

Colorado's recycling rate is below the national average, and lawmakers looked at ways to make it easier to recycle across the state. <u>House Bill 22-1355</u> creates a producer responsibility statewide recycling program and requires the Colorado Department of Public Health and Environment

Executive Director to select a nonprofit organization to implement it. The program must providerecycling serv ices to residences, businesses, schools, hospitality services, government buildings, and public spaces. Producers of packaging materials and paper products will pay annual dues to fund the project.

## FAMILY ACTIVITIES Idella Lewis & Karen Baxter

The Family Activities shares two chairpersons, Idella Lewis and Karen Baxter. Idella writes the news articles for the *Granger* and assists with entering the entries at the State Session and is present during the judging. Karen enters the entries at the State Session and assists during the judging. Awards are handed out by both.

In 2021 there was an increase in the number of entries with a total of 76 entries in the baking and needlework events. The top number of entries was Mt. Allison with a total of 23 entries, Golden Gate 20 entries, and Marvel, 13. Also participating were Maple Grove, Enterprise, Fountain, and Florissant.

The bake sale held after the judging was quite successful.

The National Quilt Block contest pattern was "Wonky Star." The deadline for entries was Sept. 1<sup>st</sup>, which was earlier than in previous years. The contest was open to members and prospective members with categories for adults, youth, and men. Monetary prizes are awarded for first, second, and third place, and ribbons given to all entries. Entries are retained by the National Grange and will be made into finished quilts to be sold at a later date to raise funds for the Grange Foundation, a 501(c)(3) non-profit entity.

Each Grange can do their part to increase awareness and participation of contest events by promoting the various events. It is always interesting to see the entries on display at the State Session. There are many talented Grangers! Remember to follow the rules in the handbook. The new Grange year begins Sept. 1<sup>st</sup> so items should be made during the new Grange year, beginning Sept. 1<sup>st</sup> 2022-23. Start working on those projects for next year's contest now! Donations of items made are also welcome in your own community to make life better for those less fortunate.

## **Mandy Project Report Cindy Greer, Director**

The Mandy project through the Colorado State Grange and P.I.C.K. has helped 143 Children obtain services pertaining to their hearing loss for the last 24 years. You should be proud of your contributions to this project. It's one way that we get the Grange name out to the public. Thank you for your continued support and promotion of this project.

Thank you to Amy Peterson, Audrey Maydew, Cyndi Charbonneau and Ruth Wilson Francisco for serving on the committee to review applications. Email makes sending copies of the applications and information easy and that is how we discuss and make decisions.

We received only one application this year and the committee that reviews the application awarded the family \$2,000.00. \$1,000.00 from the Colorado State Grange Funds and \$1,000.00 from PICK funds.

Haddie Phrase is 11 years old and attends Alamosa Elementary School. Mandi Phrase is a single mom of four children. Haddie spent most of her early life in a Dominican orphanage. The genetic components of her hearing loss are completely unknown, but she did suffer from a lack of stimulation there. She was quite developmentally behind upon joining her forever family. Haddie has worked hard to catch up and develop skills similar to her peers. In addition to hearing loss, Haddie has been diagnosed with a learning disability in math. Haddie received further evaluation after a hearing screening at school. She suffers from bilateral sensorineural hearing loss. Her loss is moderate. As there is no treatment or surgery, she will likely need hearing aids for the rest of her life.

Haddie has overcome so much in her short life. There is no limit to what she can accomplish. Right now, she says she wants to be a teacher or a veterinarian. She wants to attend college, live independently, and have a family. I am committed to helping her pursue these goals. In the short term, Mom wants Haddie to develop confidence around her identity: as an adopted child, as a girl with hearing loss, and as a student with a learning disability. She is currently receiving Speech Therapy and is on an IEP at school.

Haddie's hearing aids were \$5000 in total. This included the molds for her ears and an FM microphone. Insurance does not cover any of these materials. She is also receiving Speech Therapy once a week. Insurance is covering a portion of these costs (currently about 50%), but will only cover 20 sessions per year. Haddie will need more than this. Even if she only attended 20 sessions, the out-of-pocket cost for the family would be \$1500.

Pleasant Park Grange and Enterprise Grange donated to the Mandy project this year. We also receive quarterly money from Amazon Smile, it's not a large amount, but every little bit helps.

The EC has recently felt that Lincoln has been more aggressive with our investments than what we had originally agreed to when we began our relationship with Lincoln.

With that being said and reviewing Kuss' plan for our investments, I (Larry Corman) move that we divest from Lincoln Investments, moving all of those funds to LPL, under the advisement and direction of Rachel Kuss. I further move that the funds be invested in the "Total Return" portfolio as presented by Rachel Kuss. I further move that Cindy Greer, secretary; Sheryl Ayers, treasurer; and Gary Wardle, president are signers on the account. Motion was seconded and carried with (Gary W., Larry C., Tom C. and Harry G. voting).

1/20/22 Larry Corman moved to pay the United States Liability Insurance company \$284.00 for Liability Insurance. Harry seconded the motion. Most was approved (Larry C, Harry G, Gary W, Tom C,)

2/10/22 Motion was made to pay Mike Lackey for legislative lobby registration fees of \$40. Seconded and carried.

#### **Granges:**

Fountain Valley – signed letter surrendering charter will be dropped on this first quarters report. Regalia and items at Beverly Weinert's house we need to get.

All Granges 4<sup>th</sup> quarter reports and dues payment received.

Gary W moved that Marvel Grange receive a new Implement box from one of ones in storage in the trailer. Seconded and carried.

#### **Old Business**

Discussion was held on insuring trailer and its contents. Information was received from insurance company and sent out via e-mail but no decision was made. The towing individual needs to talk to their personal insurance company about liability if trailer caused damage to someone else. Larry did not think it was worth the money to cover what we have. The one thing we are doing that makes us in compliance is the AIL insurance and as long as we continue to do that we qualify. C8 is supposed to operate under lodge system, following by-laws, following opening and closing ceremonies and should wear regalia at meetings. If President Biden get the IRS agents he wants, the Grange may have to answer more questions. The other thing we could do is apply to be a 501c10 (does not require lodge system.) but we don't know what it would cost to change.

National Grange building has two or three offers and some other. They have made a counter offer and the building could possibly be sold by April. If that happens, the Grange would need to be out by October.

Insurance was discussed and how long records should be kept. Some States have had to go back 50 years to see who the insurance company was at the time of an incident that is now is court. So basically, we need to keep records forever. Termination of membership was an issue in one of the states.

Florida State Grange turned in their charter.

We discussed bonding for state Grange. It was decided that we needed to cover close to \$900,000.00 with the total funds that we have. Gary W. will e-mail National President, Betsy H. for information about cost for bonding on \$900,000.00 and we will discuss via e-mail.

Review of books – Sheryl A. will contact Valerie Borge about reviewing the books before our next meeting.

## **New Business:**

Cindy G. renewed her raffle manager's license. Gary W. moved we renew the raffle license. Seconded and carried. Larry filed the report for the last quarter. It takes about three months to get the report approved.

State Session was discussed. Gary W. will go look for possible motels and contact Beverly Weinert. He has talked to Beverly's daughter about meals but have not heard back from them. Gary W. thought last year's agenda worked well with the sixth degree on Saturday afternoon. Gary W. will work on getting a speaker. National Representative was discussed. get the information into the books. Harry Greer moved that we do a two-year review of books at Valerie Barge's schedule. Seconded and carried.

State Session – Gary reported that he has tried to get the Water Conservation Board to update us on the Colorado's Water Plan, which might be a zoom conference. He hasn't been able to get a hold of anyone at the Garden of the Gods. The National Reps will do the installation of officers. National President has sent an e-mail with her video to present at State Session. Discussed gift for National Representatives.

Harry Greer shared that at National last year, Kansas had some easy curtain set up. He thought we need three frames. Total cost of frames and curtains would be around \$300.00. Gary Wardle moved we purchase the frame and curtains. Seconded and carried. The old curtains will be offered to any Grange that needs them and see if we could get something for them.

We need to get someone to fill the Flora position for Thursday and Friday(maybe). Gary asked about the filling the Flora position on Thursday. Gary W. will talk to Carol Lackey.

Trailer was discussed. Most of the heavy stuff is out of the trailer which will make it easier to haul. Gary. asked if there was any maintenance that needed done on the trailer. Harry G said that he didn't know of any.

Harry Greer will do the short for fifth degree.

Pleasant Park donated a fed, white, and blue Afghan that will be auctioned off at State session and we will decide where to put the funds prior to the auction.

LPL Financial policy statement had been worked on via e-mail without finalizing it. Larry will work on getting that finalized in the near future via e-mail.

Investment committee was discussed as to whether to have a resolution or the Master appoint. The Investment committee would review the investment quarterly and make any recommendations to the executive committee. We are paying LPL advisors for what they are doing and they have a lot of experience. Harry Greer suggested we remove the "Invest committee" out of the Investment policy. All were in agreement. New Business:

Custodial accounts – location of funds – Sunflower \$48,475.91, Deer Trail \$5,000.00 (2016), Lake Side \$12,631.99, Mountain View \$601.56 are located in Invested funds with other money that is CSG money. Eureka (maybe under \$17,155.000) and Riverside (Under \$10,000.00) still have funds. It was suggested that Valerie B. who will review the books might have a suggestion or perhaps our LPL representative would have suggestions. Actual money is in LPL with Colorado State Grange funds.

Larry Corman presented a proposed budget. It was discussed and edited and will be presented at State Session.

The committee approved Pikes Peak Pomona having one delegate when they pay their dues and assessment fee.

Discussion was held as to raffle account expenditures and the budget. The Colorado Secretary of State requires that the Raffle have a separate account and checks have to be written from the Raffle account to help individuals with expenses for leadership conferences, which are not included in the budget. Even though this does not give an accurate reflection of what the CSG does, we are unable to predict how much a raffle will bring in and what we are able to help individuals with. Therefore, it was decided that we do not need to include in the budget.

Master's report – Gary shared that he had been busy getting all the state session prep done. He has participated in Wheat Ridge Grange, Darden Pomona and Enterprise Grange activities.

Overseer's Report - Harry Greer said he worked at the La Plata County Fair La Plata Pomona Grange food concession. They missed Pomona picnic due to a funeral, and are going to State fair on Thursday to set up the display.

Ex committee report - Tom Campion and Larry Corman both attended the La Plata Pomona Picnic, it was quite cool. Larry caught a chill. They played games. Tom met some new Grangers but didn't get them convinced to come to State. Larry helped at the County fair flipping hamburgers.

Sec report – Cindy Greer said that she has received a few delegate forms and meal reservations and some Subordinate reports of officers for 23. She has the display ready to take to the state Fair to set up. We have not

received any reports from officers or directors for state session yet. Next Colorado Granger articles are at the printer, time will tell how long it takes the post office to get it out.

#### GOTO-101-CO

#### **Golden Sheaf Dues clarification**

- 1. WHEREAS: The Colorado State Grange By-laws states: <u>Section 8.</u> The Colorado State Grange authorizes the Golden Sheaf Class of Membership (50 years). Members who obtained Golden Sheaf Membership status prior to December 31, 2000, are relieved from payment of dues at all levels of Grange. **Members who obtained Golden Sheaf Membership status after January 1, 2001 will pay one half the dues that other regular members pay to their Subordinate Grange.** Those dues will then be forwarded to the State Grange to then be forwarded to the National Grange.
- 2. WHEREAS: National Grange requires full payment of National dues for those who have obtained their Golden Sheaf membership after January 1, 2001 and
- 3. WHEREAS: The intent of the Colorado State Grange By -laws was to apply to only the dues paid to Colorado State Grange and
- 4. WHEREAS the current language of the CSG by-laws could be interpreted as applying to all dues at all levels, now therefore be it
- 5. RESOLVED that the Colorado State Grange by-laws be clarified with the following language: "Members who obtained Golden Sheaf Membership status after December 31, 2000 will pay one half of the dues for the Colorado State Grange and pay the full amount of National dues."

# GOTO 102 - CO

## **Grange IRS compliance**

- 1. **WHEREAS**; The Grange has tax status of 501-c 5, 501-c 8, and 501-c10 because we are in the Lodge classification, and
- 2. WHEREAS; The Lodge classification is dependent on the Granges following an accepted ritual, and
- 3. WHEREAS: Officer titles, are part of the prescribed ritual, and
- 4. WHEREAS; Following an accepted meeting format, are also part of the Ritual and
- 5. **WHEREAS**; The Grange ritual and officer titles (Master, Overseer, Lecturer, Steward, A.S., L.A.S., Chaplain, Sec, Treas, Gate Keeper, Ceres, Pomona, Flora, Executive Committee as in the 1957 digest) were accepted by the IRS prior to the Granges receiving the tax status, therefor be it
- 6. **RESOLVED**; All Granges follow the IRS accepted ritual for their meetings, including, National Grange, State Granges, Pomona Granges, Subordinate Granges, and Junior Granges, and be it further
- 7. **RESOLVED**; All Granges must use the titles of officers that have been accepted by the IRS, (Master, Overseer, Lecturer, Steward, A.S., L.A.S., Chaplain, Sec, Treas, Gate Keeper, Ceres, Pomona, Flora, Executive Committee as in the 1957 digest) in their formal meetings, and all internal communications, until the time that new titles are accepted by the IRS, and be it further
- 8. **RESOLVED**; The National Grange, and all State Granges provide information to the members of their respective Granges advising subordinate Granges which officer titles, and which meeting formats have been accepted by the IRS, in complying with the classification of a "Lodge" for tax classification purposes.

## GOTO 103 CO CSG INVESTMENT POLICY

- 1. WHEREAS; The Colorado State Grange has invested monies that are custodial accounts for Granges who have sold building or banks funds from Granges who have relinquished their charter or funds donated for special activities and monies from the sale of the Colorado State Grange Building, and
- 2. WHEREAS; The current Executive Committee feels the monies should be protected in the future as they currently are protected, and
- 3. WHEREAS; the executive committee has crafted a written policy that can be changed by the delegates of the Colorado State Grange by a majority of voting delegates attending the Colorado State Session when the changes are presented in the form of a resolution, therefore be it
- 4. RESOLVED; The Colorado State Grange supports the introduction of an Investment Committee, and be it further
- 5. RESOLVED; the investment Committee shall consist of the Master, Overseer, Executive Committee, Treasurer, and Secretary of the Colorado State Grange, and be it further
- 6. RESOLVED; the Colorado State Grange accepts the following policy to be followed by the Investment Committee when making decisions concerning the Colorado State Grange invested funds. (See next page or back of this document).

## <u>Investment Policy of</u> the Colorado State Grange

#### **Purpose:**

The investments of the Colorado State Grange (CSG) are to support the operations and policy efforts of the Grange and the Subordinate Granges of the State of Colorado and to hold in escrow(custodial) funds that are turned over to CSG by Subordinate Granges from whatever source according to the applicable rules of CSG and the National Grange. This policy shall remain in place until changed by action of the CSG at a state convention after approval by the Executive Committee (Ex Com) of the CSG.

## **Delegation of Responsibilities:**

Per Section 4 of the CSG Constitution,

It shall be the duty of the Treasurer of the Colorado State Grange to oversee the invested funds (in conjunction with the Executive Committee).

The Executive Committee has the ultimate responsibility for all investments, and will review all investments once a year at a minimum.

## **Management of Accounts:**

A professional financial management firm (**Investment Manager**) will manage all aspects of the CSG invested funds. Any withdrawals/deposits will be by approval of the CSG Executive Committee. The CSG Executive Committee along with the secretary and treasurer have "read only" online access to the funds.

#### **Guidelines for Investment:**

The CSG Executive Committee defers to the Investment Manager in day-to-day investment decisions. The Investment Manager should invest in a diversified manner that reduces risk while generating income to support CSG's operational needs.

#### **Performance Measurement Standards:**

Investments will be compared with commonly used investment benchmarks such as Standard and Poor's 500 Composite Index.

#### **Expenditures of Funds:**

Non-escrowed or otherwise earmarked funds may be used as needed for the operation of the CSG.

#### **Donor Restrictions:**

Donors may restrict the uses of their donated funds. Donations may be made to any of the special funds that are maintained by the CSG (e.g., Mandy Project, Youth Fund, etc.). These restricted funds shall be tracked by the secretary/treasurer with guidance from the Ex-Com.

### **Reserve Fund Expenditures:**

The Ex Com may use income from non-escrowed funds or return on investment from restricted funds as needed for the ongoing operation of the CSG.

## **Real Property:**

The CSG does not currently own any real property. In the event that this should change any real property will be considered as part of the investment portfolio.

## GOTO - 104-CO Secretary's membership Records

- 1. WHEREAS: it is important that the membership records in each Grange be kept up to date, and
- 2. WHEREAS: when a Granger passes away or leaves the Grange that information is not always passed on to the Pomona, therefore be it
- 3. RESOLVED, when a community Grange secretary removes a name from their membership roles that information is communicated to the Pomona Grange in that area.
